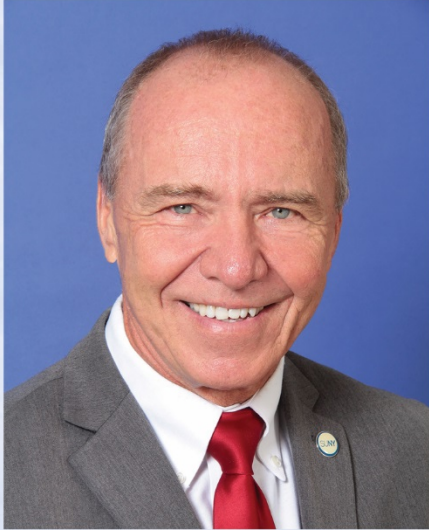

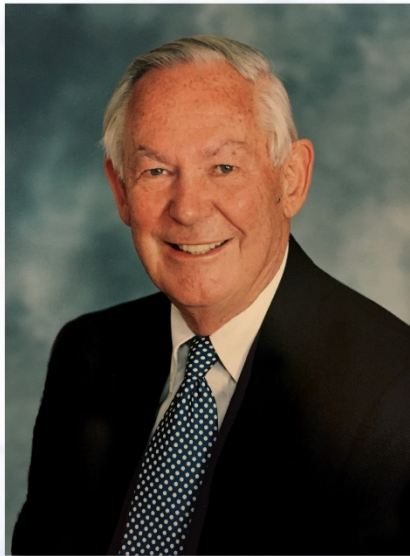

Among her many affiliations, she holds the office of secretary of the SUNY Ulster Board of Trustees and is a director on the Foundation Board. Ms. St. John-Gilligan is a tireless community volunteer and an on-going advocate on behalf of SUNY Ulster. She has made major contributions to establish the St. John Family Fund for Excellence with the Foundation in addition to her charitable giving throughout the year.
